TSHBeFit Monthly Sweepstakes – Official Rules

- 1. SWEEPSTAKES DESCRIPTION. These official rules ("Official Rules") apply to the "TSHBeFit Monthly Sweepstakes" (the "Monthly Sweepstakes") offered by FBS-HIA, LLC ("FBS") through the TSHBeFit program (the "Program"). Eligible participants will be offered the chance to win a \$75 Visa gift cards. There is no additional purchase necessary to enter or win the Monthly Sweepstakes. A purchase will not improve one's chances of winning. The Monthly Sweepstakes is sponsored by FBS ("Sponsor"). See Section 17 for additional Sponsor information.
- 2. **PRIZE DESCRIPTION AND CONDITIONS**: Two \$75 Visa Gift cards. Two winners will be selected each month during the Monthly Sweepstakes Period. An individual may only win once during the Entry Period.
- 3. **ENTRY PERIOD**: The first drawing will begin midnight CST on September 1, 2023, and will end at 11:59pm CST September 30, 2023. Thereafter, the Monthly Sweepstakes will begin at midnight CST on the first day of each month and end at 11:59pm CST on the last day of the month ("Monthly Sweepstakes Period"). Entries will be accepted throughout each Monthly Sweepstakes Period. Any entry received after the close of the Monthly Sweepstakes Period will be submitted in the next Monthly Sweepstakes Period. The Entry Period, which begins at midnight CST on September 1, 2023, will terminate at 11:59pm CST on August 31, 2024. Any entries after August 31, 2024, will be ineligible for any prize.
- 4. **ELIGIBILITY**: This Monthly Sweepstakes is only open to legal residents of Texas who are participating in the Program. Participation is void outside of Texas. Entrants must be at least 18 years of age or older at time of entry. Employees of Sponsor and their immediate families (i.e., parents, spouse, children, siblings, grandparents, stepparents, stepchildren, and stepsiblings) and of any affiliated companies, sponsors, advertising agencies, and third-party fulfillment agencies are not eligible to enter or win.

Further, no entrant shall hold himself or herself out as an agent or representative of Sponsor. The Sponsor expressly disclaims any responsibility or liability for injury or loss to any person or property relating to the delivery or subsequent use and redemption of any Prize. The Sponsor makes no representations or warranties (express or implied) concerning the appearance, safety, or performance of any Prize. Restrictions, conditions, and limitations apply. Sponsor is not liable to replace any lost or stolen element of any Prize. Designation as a Prize Winner is not transferable or assignable to any other person or entity. SPONSOR HAS NOT MADE AND EXPRESSLY DISCLAIMS ANY WARRANTY, REPRESENTATION, OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT ORIN LAW, RELATING TO THE PRIZE, EXCEPT, IN THE CASE OF SPONSOR, AS EXPLICTLY STATED IN THESE OFFICIAL RULES.
- 10. **SPONSOR'S RULES DISCRETION**: All interpretations of these Official Rules and decisions by Sponsor are final. Sponsor reserves the right to reject any entries in the Monthly Sweepstakes or any Entrant's activities associated therewith that may be deemed, in Sponsor's sole discretion, to violate these Official Rules or any policies or guidelines established by Sponsor that govern Entrants' participation in the Monthly Sweepstakes. Sponsor reserves the right, in its sole discretion, disqualify any Entrant or other party for any reason, including those Entrants it finds to (a) have tampered with the entry process
